**Subject: Standing Cost Committee (SCC) to examine project cost under various phases of NHDP-reg.**

Standing Cost Committee (SCC) has been constituted under the chairmanship of AS&FA (RT&H) vide Ministry's OM No. RW/NH-37011/2/2009-PPP dated 28.09.2010. This committee has been constituted to examine the cost aspects of road projects under various phases of NHDP, having project cost more than normative cost as suggested by BKC Committee prior to referring the proposal to EFC/SFC/PPPAC. In this regard, O.M. 24036/27/2010-PPP (Pt) 30 October 2015 was issued. Now, Competent Authority has decided to amend the O.M. dated 30 October 2015 and Para (i) and (ii) may please be read as under.

- i. For Projects with Total Project Cost more than Rs. 1000 crores and the average cost more than the normative updated cost shall continue to be examined by "Standing Cost Committee" irrespective of mode of delivery before circulating the same for EFC/PPPAC as the case may be.
- ii. For Projects with Total Project Cost upto Rs. 1000 crores and the average cost NOT MORE THAN 20% of the normative updated cost, the cost aspect including its financial sustainability shall be examined and deliberated by EFC/SFC, irrespective of the mode of delivery. If it exceeds 20% of normative cost, the project shall be examined by Standing Cost Committee and its recommendations placed before the EFC/SFC for appraisal.
